# Danish trade with Kosovo

- Goods exports to Kosovo fell by 10,4 % in 2023 in relation to 2022. (FOS)
- The top export in 2023 was road vehicles (including air-cushion vehicles) (DKK 18,1 million). (FOS)
- In the first two months of 2024, Danish exports of goods to Kosovo were worth DKK 9,4 million; a fall of 40,5% relative to the same time period in 2023 (DKK 15,8 million). (FOS)

- Imports of goods from Kosovo totalled DKK 13 million in 2023; a rise of 124,3% relative to 2022.(FOS)
- The top import good in 2023 was furniture and parts thereof (DKK 5,4 million). (FOS)
- In the first two months of 2024, imports of goods from Kosovo were worth DKK 2,8 million; a rise of 16,1% in relation to the same time period in 2023 (DKK 2,4 million). (FOS)

# Economic key figures for Kosovo

- Kosovo was the world's 158th largest economy in 2022 with a GDP of 9.410 million USD.
- In 2022 the country had a population of 1,8 million.
- According to the World Bank's 2022 classification, Kosovo belongs to the group of Upper middle income countries. The GDP per capita of the country was 5.341 USD in 2022.
- In 2024 the real growth rate in GDP is expected to be 3,9 pct., and over the following two years real GDP is expected to grow at a rate of 3,9 pct. p.a.
- In 2022 the current account had a deficit of 10,3 pct. of GDP. Towards 2025, the current account is expected to strongly improve, but remains negative.
- In 2022 the government budget balance had a deficit of 0,7 pct. Towards 2025, the budget balance is expected to somewhat worsen and the deficit increases further.
- Total goverment debt is expected to increase to 21,9 pct. of GDP in 2025.
